#### PREAMBULE - PANNINGPME WEB ACCESS

PlanningPME Web Access is the Web version of the scheduling software PlanningPME.

The application allows you to manage the schedule of your via a web browser such as Microsoft Internet Explorer, Mozilla Firefox, Google Chrome, Safari ...

You will need to type a login and a password to have access to your schedule.

The set up is only running from Windows Server 2008.

IIS 7 (Services Internet) MUST be installed on the server that hosts the web application.

Databases compatible with PlanningPME Web Access are SQL Server and My SQL.

#### **DEFINITIONS**

RESELLER: Authorized Reseller, intermediate in selling

CLIENT: Final User of the software, he can be CLIENT when Direct Selling, he can be CLIENT when Authorized Reseller sold the software

# ARTICLE 1 - OBJECT OF THE CONTRACT

The subscription of the service or product by the CLIENT is done by signing and sending the purchase order by mail, email or fax to the company TARGET SKILLS or to the RESELLER.

The service is activated by the company TARGET SKILLS after:

- A) reception of the quote and GUC dated and signed by the CLIENT with the company stamp and the amount invoiced;
- B) reception of the order dated and signed by the RESELLER with the Client's company data and the amount invoiced and GUC approved by the Client;

### ARTICLE 2 - OBJECT OF THE GENERAL CONDITIONS - SERVICES

# 2.1. - Object of the general conditions

These terms are intended to define the respective obligations of each party for the services agreement concluded and accessible via the hosted web site.

#### 2.2. - Services

The company TARGET SKILLS designed and built a website with a private paying access dedicated to sharing a schedule among multiple users.

The company TARGET SKILLS provides to CLIENTS various services including:

- Secured Connection with login and password access.
- Choice of the agenda view
- Daily navigation, multi-day, weekly, monthly, bimonthly, biannual, annual.
- Entering events in the navigation above.
- Search events based on their text, date or time.

- Visualization of changes made by users of the schedule (add, modify, delete)
- Setting personal user data

#### ARTICLE 4 - ACCESS TO SERVER - OPENING AN ACCOUNT

4.1. - Access to Server - Opening and using the PlanningPME WebAccess Account.

The company TARGET SKILLS supports and exclusively controls the opening of accounts for PlanningPME Web Access. As such, it only provides the CLIENT means of identification and secure access to the service: the company TARGET SKILLS provides the CLIENT a username (called "login") and a password.

The company TARGET SKILLS is committed to monitoring and perform technical maintenance service in conjunction with its hosting server so that the CLIENT can connect optimally for the duration of the contract.

#### 4.2. SECURITY - USE OF IDENTIFIERS

So the CLIENT will receive an ID from the company TARGET SKILLS. It has a username and / or password chosen by TARGET SKILLS.

The CLIENT is responsible for full and exclusive use of his / her login and password. The CLIENT alone bears the consequences and the responsibility that may result from usage by others who were aware of them.

The CLIENT is solely responsible for the use of the services available on the website https://cli.planningpme.com/Company\_Name and the services relating thereto are to be made under his credentials, until he asked the company TARGET SKILLS to change its password.

# **ARTICLE 5** - GENERAL OBLIGATIONS OF CLIENTS

The CLIENT declares to be of legal age and have full legal capacity to engage under these terms and conditions.

The CLIENT obliges to submit all information, including administrative, necessary for identification and qualification, to open an account.

Generally, the CLIENT agrees to:

- Meet the legal requirements, regulatory, conventional as well as customs and trade practices to which it is subjected;
- Comply with all legal and regulatory requirements relating to computers, files and freedoms, and to this end, to make any request by authorizations or useful statement of processing with the National Commission of Informatique et des Libertés (CNIL) or any administrative authority which replaces it;
- Keep the information confidential contained on the site;

 Not to submit, copy, sell or otherwise dispose any form, any information received, available to another person or entity;

The CLIENT acknowledges the provisions of Article 6 of Act II of June 21, 2004 which states that the persons mentioned in 1 and 2 Act I own and retain the data will allow the identification of any person who has contributed to the creation of content or a content of service providers they are.
